#### "FABULOUS FLORIDA"

#### **ARTIST'S REQUIREMENTS:**

- 1. Artwork must have the artist's name, title, and phone number on the back.
- 2. Artwork will not be accepted after Receiving.
- 3. Artwork that is sold may not be removed until the end of the exhibit, nor can it be replaced with another piece.
- 4. Title cards with price and artist name are provided as well as CCAC paperwork at receiving.
- 5. SWFFCG reserves the right to jury out artwork that is unfinished, damaged, or of poor quality.
- Any declined artwork should be picked up on Receiving day or it will be returned to the SWFFCG storage closet at the CCAC. The artist understands that neither the SWFFCG nor CCAC have any responsibility for artwork removed promptly.
- 7. Hanging art must be ready with all necessary hangers. Wall pieces must have wire that is attached a minimum of 3" from top of frame and be wrapped, so it is not visible when hung. No sawtoothed hangers are allowed.
- 8. A non-refundable entry fee is due to the SWFFCG in the amount of \$25 for up to two pieces.
- Cape Coral Art Center retains a 30% commission on sales, not including the squares which will be sold directly by the guild. Please take this into consideration when pricing your work.
- 10. Cannot have been previously shown at the Cape Coral Art Center.

#### **RELEASE WAIVER & AGREEMENT**

RESPONSIBILITY: While every effort will be made to handle artwork with care and protect it from loss, neither the Southwest Florida Fine Craft Guild nor the Cape Coral Art Center will be liable for damage or loss.

Submission of work for this exhibit and the signing of the Release Waiver below will constitute an agreement to these conditions including honoring dates and times for receiving and removal and giving permission to allow photography for publicity purposes.

All entries must be TITLED and be FOR SALE.

The artist agrees to all provisions of this prospectus and agrees that any person other than the artist delivering or removing their work has also read and agreed to the terms of this prospectus.

The artist confirms that the work is original and understands that any work found to be a duplicate or in violation of copyright law will be excluded from the exhibit and disallowed from any awards or prizes.
